Error / Penalty 4
 • Work outside course boundary • 3rd refusal or evade
 • Wrong obstacle wrong • Wrong line of travel • Work-
 ing outside course boundary • 3rd refusal or evade
 • Tipping the rope gate and not picking it up • Fall
 to complete obstacle • Excessively or repeatedly
 touching horse • Overturns of more than 1/4 turn
 No attempt to perform obstacle • Performing
 obstacles out of order • In-hand: Horse gets loose or
 leading on the wrong side
